MINUTES OF SANITARY & IMPROVEMENT DISTRICT NO. 8 OF SAUNDERS COUNTY, NEBRASKA

On September 10, 2018 at 5:30 p.m., a Budget Hearing, Levy Hearing, Schedule A Rate Schedule Hearing, and regular meeting of the Chairman and Board of Trustees of the Sanitary & Improvement District No. 8 of Saunders County, Nebraska, was convened in open and public session at the Woodcliff Community Center located at Woodcliff Lakes, Inc., Tract 8, 980 County Road W, Fremont, Nebraska 68025.

Timely notice of the hearings and meetings was given to the public by publication, notice and the proposed agenda was timely given to all members of the Board of Trustees, and notice was timely given to the Saunders County Clerk and the Fremont City Clerk. Availability of the agenda was communicated in said notices. These minutes were written and available for public inspection at the office of Woodcliff Lakes, Inc., within ten working days or prior to the next convened meeting, whichever was earlier. It was stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and the location of the copy of said Act was indicated. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Business conducted and decisions made were as follows.

Budget Hearing at 5:30 p.m.

1. The Budget Hearing was advertised in the Fremont Tribune. Chairman Lonnie Mahrt called the meeting to order.

Kent Speicher from Erickson & Brooks, CPA, went over the budget and assessment for the 2018-2019 fiscal year, past and future expenses and income were discussed. The need for 1% increase in restricted funds was discussed.

Whereupon a Motion for Adjournment of the Budget Hearing was made by Trustee Taylor, and seconded by Trustee Sawyer, and on roll call vote was unanimously approved by the Chairman and all Trustees present, and declared duly adopted by the Chairman, at which point the Budget Hearing adjourned.

Levy Hearing at 5:40 p.m.

2. The Levy Hearing was advertised in the Fremont Tribune. Chairman Lonnie Mahrt called the meeting to order.

Kent Speicher went over the new valuations, discussion was had.

Whereupon a Motion for Adjournment of the Levy Hearing was made by Trustee Sawyer, and seconded by Trustee Taylor, and on roll call vote was unanimously approved by the Chairman

and all Trustees present, and declared duly adopted by the Chairman, at which point the Levy Hearing adjourned.

Schedule A Rate Schedule Hearing at 5:45pm

3. The Chairman announced that pursuant to posted and published notice, affidavit copies of which are attached to these minutes, that the Board would now conduct a public hearing on proposed amendment to the Schedule A Rate Schedule for the District's water and sewer systems that would change the annual fee per Lot from \$125.00 to \$150.00 beginning with the calendar year 2019. Whereupon comment was solicited from members of the public and thereafter from any Trustees regarding the proposed rules change.

Whereupon a Motion for Adjournment of the Schedule A Rate Schedule Hearing was made by Trustee Sawyer, and seconded by Trustee Taylor, and on roll call vote was unanimously approved by the Chairman and all Trustees present, and declared duly adopted by the Chairman, at which point the Schedule A Rate Schedule Hearing adjourned.

Meeting at 5:50 p.m.

- 4. The Meeting was advertised in the Fremont Tribune and Wahoo Newspaper. Chairman Lonnie Mahrt called the meeting to order.
- 5. After the discussion of past expenses and next year's expected expenses, it was moved by Trustee Taylor and seconded by Trustee Sawyer to increase the restricted funds budget an additional one percent (1%) as allowed by state law. Upon roll call vote, voting YES were Trustees Mahrt, Sawyer, Borman, Taylor; voting NO were Trustees NONE; absent was Trustee Kenney; abstaining were NONE; which was 100% of all Trustees present in favor; whereupon the motion was declared adopted by the Chairman.

Ordinance 2018-01, copy attached to these minutes, was then moved for adoption by Trustee Sawyer and seconded by Trustee Taylor, said ordinance to adopt budget and waive the three readings for appropriations as otherwise required. Upon roll call vote, voting YES were Trustees Mahrt, Sawyer, Borman, Taylor; voting NO were trustees None; absent was Trustee Kenney; abstaining were NONE; whereupon the ordinance was declared adopted by the Chairman.

Resolution 2018-06, copy attached to these minutes, was then moved for adoption by Trustee Taylor and seconded by Trustee Sawyer, said resolution to set the levy of the District for the 2018-2019 fiscal year at \$148,598 for the general fund, which is at a levy rate of .106554 per \$100 valuation; and at \$111,566 for the sinking fund, which is at a levy rate of .080000 per \$100 valuation; and at \$56,712 for the bond fund, which is at a levy rate of .040665 per \$100 valuation. Upon roll call vote, voting YES were Trustees Mahrt, Sawyer, Borman, and Taylor; voting NO were trustees None; absent was Trustee Kenney; abstaining were NONE; whereupon the resolution was declared adopted by the chairman.

Annual statement of SID 8 status, a copy of which is attached to these minutes, was then moved for adoption; Motion made by Trustee Taylor and seconded by Trustee Sawyer. Upon roll call vote, voting YES were Trustees Mahrt, Sawyer, Borman, Taylor; voting NO were Trustees NONE; absent was Trustee Kenney; abstaining were NONE; whereupon the motion was declared adopted by the Chairman.

Discussion of an increase in the annual utility fund rate was had. Resolution No. 2018-07, copy attached to these minutes, was then moved for adoption by Trustee Taylor and seconded by Trustee Sawyer to implement a \$25 increase in the annual utility fund fee which would change it from \$125 per year to \$150 per year, beginning January 1, 2019. Upon roll call vote, voting YES were Trustees Borman, Mahrt, Sawyer and Taylor; voting NO were Trustees NONE; absent was Trustee Kenney; abstaining were NONE; whereupon the motion was declared adopted by the Chairman.

- 6. Minutes of meeting held on August 6, 2018 were approved by unanimous consent of those Trustees present.

Upon roll call vote, voting YES were Trustees Borman, Mahrt, Sawyer and Taylor; voting NO were Trustees NONE; absent was Trustee Kenney; abstaining were NONE; whereupon the motion was declared adopted by the Chairman.

ORDINANCE NO. 2018-01

AN ORDINANCE TO ADOPT THE BUDGET STATEMENT TO BE TERMED THE ANNUAL APPROPRIATION BILL; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRPERSON AND THE BOARD MEMBERS OF THE SANITARY AND IMPROVEMENT DISTRICT NO. 8 OF SAUNDERS COUNTY, NEBRASKA.

Section 1. That after complying with all procedures required by law, the budget presented and set forth in the budget statement is hereby approved as the Annual Appropriation Bill for the fiscal year beginning July 1, 2018, through June 30, 2019. All sums of money contained in the budget statement are hereby appropriated for the necessary expenses and liabilities of the District. A copy of the budget document shall be forwarded as provided by law to the Auditor of Public Accounts, State Capitol, Lincoln, Nebraska, and to the County Clerk of Saunders County, Nebraska, for use by the levying authority.

Section 2. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
