## MINUTES OF SANITARY & IMPROVEMENT DISTRICT NO. 8 OF SAUNDERS COUNTY, NEBRASKA

On \_September 10 \_, 2019\_\_ at \_5:30\_ p.m., a Budget Hearing, Levy Hearing, and regular meeting of the Chairman and Board of Trustees of the Sanitary and Improvement District No. 8 of Saunders County, Nebraska, was convened in open and public session at the Woodcliff Lakes Inc. office, 980 County Road W, Lot T1018A, Fremont, Nebraska 68025.

Timely notice of the hearings and meeting was given to the public by publication, notice and the proposed agenda was timely given to all members of the Board of Trustees, and notice was timely given to the Saunders County Clerk and the Fremont City Clerk. Availability of the agenda was communicated in said notices. These minutes were written and available for public inspection at the office of Woodcliff Lakes, Inc., within ten working days or prior to the next convened meeting, whichever was earlier. It was stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and the location of the copy of said Act was indicated. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. Business conducted and decisions made were as follows.

## Budget Hearing at 5:30pm

1 The Budget Hearing was advertised in the Fremont Tribune. Chairman Lonnie Mahrt called the meeting to order.

Kent Speicher from Erickson & Brooks, CPA, went over the budget and assessment for the 2019-2020 fiscal year; past and future expenses and income were discussed. The need for 1% increase in restricted funds was discussed.

Whereupon a Motion for Adjournment of the Budget Hearing was made by Trustee Sawyer and seconded by Trustee Borman and on roll call vote was unanimously approved by the Chairman and all Trustees present, and declared duly adopted by the chairman, at which point the Budget Hearing adjourned.

#### Levy Hearing at 5:40pm

2. The Levy Hearing was advertised in the Fremont Tribune. Chairman Lonnie Mahrt called the meeting to order.

Kent Speicher went over the new valuations and proposed levies, discussion was had.

Whereupon a Motion for Adjournment of the Budget Hearing was made by Trustee Sawyer and seconded by Trustee Kenney and on roll call vote was unanimously approved by the Chairman and all Trustees present, and declared duly adopted by the chairman, at which point the Levy Hearing adjourned.

### Meeting at 5:45pm

- 3. The Meeting was advertised in the Fremont Tribune. Chairman Lonnie Mahrt called the meeting to order.
- 4. After the discussion of past expenses and next year's expected expenses, it was moved by Trustee Kenney and seconded by Trustee Sawyer to increase the restricted funds budget an additional one percent (1%) as allowed by state law. Upon roll call vote, voting YES were Trustees Borman, Kenney, Mahrt, Sawyer, and Taylor; voting NO were Trustees NONE; absent were NONE; abstaining were NONE; which was 100% of all Trustees present in favor; whereupon the motion was declared adopted by the Chairman.

Ordinance 2019-01, copy attached to these minutes, was then moved for adoption by Trustee Kenney and seconded by Trustee Borman, said ordinance to adopt budget and waive the three readings for appropriations as otherwise required. Upon roll call vote, voting YES were Trustees Borman, Kenney, Mahrt, Sawyer, and Taylor; voting NO were Trustees NONE; absent were NONE; abstaining were NONE; whereupon the ordinance was declared adopted by the Chairman.

Resolution 2019-03, copy attached to these minutes, was then moved for adoption by Trustee Kenney and seconded by Borman, said resolution to set the levy of the District for the 2019-2020 fiscal year at \$144,585 for the general fund, which is at a levy rate of .102828 per \$100 valuation; and at \$98,426 for the sinking fund, which is at a levy rate of .070000 per \$100 valuation; and at \$82,255 for the bond fund, which is at a levy rate of .058498 per \$100 valuation. Upon roll call vote, voting YES were Trustees Borman, Kenney, Mahrt, Sawyer, and Taylor; voting NO were Trustees NONE; absent were NONE; abstaining were NONE; whereupon the resolution was declared adopted by the Chairman.

Annual statement of SID 8 status, a copy of which is attached to these minutes, was then moved for adoption; Motion made by Trustee Sawyer and seconded by Trustee Kenney. Upon roll call vote, voting YES were Trustees Borman, Kenney, Mahrt, Sawyer, and Taylor; voting NO were Trustees NONE; absent were NONE; abstaining were NONE; whereupon the motion was declared adopted by the Chairman.

Speicher then discussed and reviewed with the Board a draft of the 2019-2020 Audit.

- 5. Minutes of meeting held on August 7, 2019 were approved by unanimous consent of those Trustees present.
- 6. The following previously-issued warrants were ratified and approved; NONE.

8. JEO Engineer Tyler Hevlin reported on the 2019 Flood Projects which are in progress with FEMA and NEMA. The first project for Emergency Work has been obligated by FEMA/NEMA for a total of \$78,542.82; 75% should be covered by FEMA and 12 ½% by NEMA. The Bank Stabilization Project to repair the jetties and weirs to their original state is ready to let bids; a short meeting will be set up for a Resolution of Necessity. The Lagoon bank stabilization project needs completion of additional items for FEMA. The JEO model for the Road Elevation project will be lowered and re-submitted and phased in as soon as possible.

Hevlin also reported that the replacement of a cracked water main at the end of North Lake Shore Drive should begin in the next week or two and 120' of sheeting installed to shore up the drainage retention system there.

Dave Langenfeld will attend the Lower Platte North NRD Hazard Mitigation meeting on September  $19^{\text{th}}$ .

A written report for July 2019 from PeopleService was reviewed. Testing for copper in the water system must be completed this year. Results of a water test taken at S1204 will be forwarded to PeopleService.

The financial report through September 10, 2019 was reviewed with no action taken.

#### 9. Old Business:

Board Election ballots were to be at the Saunders County Election Office by 5pm on Tuesday, September 10<sup>th</sup> and official results should be available Friday, September 13<sup>th</sup>.

#### 10. New Business:

Discussion was held on ATV access to the river through the bank easement and Attorney Hartman was asked to investigate liability.

11. Whereupon a Motion for Adjournment was made by Trustee Taylor, seconded by Trustee Kenney, and on roll call vote was unanimously approved by the Chairman and all Trustees, and declared duly adopted by the presiding officer, at which point the meeting adjourned.

## ORDINANCE NO. 2019-1

AN ORDINANCE TO ADOPT THE BUDGET STATEMENT TO BE TERMED THE ANNUAL APPROPRIATION BILL; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRPERSON AND THE BOARD MEMBERS OF THE SANITARY AND IMPROVEMENT DISTRICT NO. 8 OF SAUNDERS COUNTY, NEBRASKA.

Section 1. That after complying with all procedures required by law, the budget presented and set forth in the budget statement is hereby approved as the Annual Appropriation Bill for the fiscal year beginning July 1, 2019, through June 30, 2020. All sums of money contained in the budget statement are hereby appropriated for the necessary expenses and liabilities of the District. A copy of the budget document shall be forwarded as provided by law to the Auditor of Public Accounts, State Capitol, Lincoln, Nebraska, and to the County Clerk of Saunders County, Nebraska, for use by the levying authority.

Section 2. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.

#### RESOLUTION NO. 2019-03

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that Governing Body of the Sanitary and Improvement District No. 8 passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

NOW, THEREFORE, the Governing Body of the Sanitary and Improvement District No. 8, resolves that:

1. The 2019-2020 property tax request be set as follows:

- 2. The total assessed value of property differs from last year's total assessed value by .825%.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$ .225360 per \$100 of assessed value.
- 4. The Governing Body of the Sanitary and Improvement District No. 8 proposed to adopt a property tax request that will cause its tax rate to be \$ .231326 per \$100 of assessed value.
- Based on the proposed property tax request and changes in other revenue, the total operating budget of the Sanitary and Improvement District No. 8 will exceed last year's total operating budget by 293.914%.
- A copy of this resolution be certified and forwarded to the County Clerk on or before October 13, 2019.
